INVITATION TO BID REHABILITATION OF COLLEGE OF ARCHITECTURE AND FINE ARTS BUILDING (REBID)

1. The Tarlac State University through the **General Appropriation Act** intends to apply the sum of **Forty Nine Million Nine Hundred Ninety Nine Thousand Nine Hundred Ninety Nine Pesos (Php 49, 999, 999.00)** being the Approved Budget for the Contract (ABC) to payment of the project: **Rehabilitation of College of Architecture and Fine Arts Building (Rebid)** received in excess of the ABC shall be automatically rejected at bid opening.
2. The Tarlac State University now invites **contractors registered with PhilGEPS** and have a **valid Philippine Contractors Accreditation Board (PCAB) license of at least Size Range Medium A, Category B** to apply for the Rehabilitation of College of Architecture and Fine Arts. Completion of the work is required within **Two Hundred Sixty (260) Calendar Days** from receipt of the Notice to Proceed.

Bidders should have completed within five (5) years from the date of submission and receipt of bids a contract similar to the Project, with at least 50% of the cost of the ABC.

3. Bidding will be conducted through open competitive bidding procedures using discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act."
